### City Manager and Director Update

### **Technology Training Rooms**

The Mt Vernon Technical Training Room in City Hall is back online starting Monday, Aug 14. You should notice some functional and aesthetic improvements to that room. IT will begin offering a standard list of technology based training classes this Fall and on regular frequencies throughout the year. You should see this roster of classes by the next Employee Newsletter. This room is available as a room resource that may be requested for reservation subject to IT approval to ensure that it does not conflict with other classes. In addition, IT is working to bring a second training facility located at the CSC building online by the end of October.

### **Transit Changes**

The transition to the city bus route changes that went into effect on July 31 has gone very well with relatively few issues. The bus routes are staying on schedule and we have received generally favorable feedback, especially in regard to the increased service frequency along 1<sup>st</sup> Ave east and more service and transfer options at Lindale, Westdale, and the NE and SW Walmarts. A few complaints have been received regarding longer travel times on a few routes, reduced service in low-use areas, frustration that changes were made, or not being aware of the route changes. The largest number of complaints have been in regard to the new circulator route in Marion. However, the changes in Marion were primarily a result of the City of Marion's request to expand service to the industrial park east of Hwy 151. We offered to provide the level of service that the City of Marion was willing to finance, including a direct connection between downtown Cedar Rapids and uptown Marion, but the City of Marion declined.

### **Fireworks Recommendation**

On Tuesday, Aug 8, a presentation was provided to the Public Safety and Youth Services Committee regarding the use and sales of fireworks. The information included statistics and an assessment of issues that occurred with the legalization of fireworks from June 1 - July 8, 2017 in Cedar Rapids. The Committee unanimously agreed to recommend to City Council a ban on the use of fireworks in city limits and allowing sales of fireworks in Industrial-zoned areas only. A resolution to proceed with establishing these recommended policies will be presented for consideration at the August 22 City Council meeting.

We have received a number of questions regarding the location of property currently zoned Industrial in relation to the sale of fireworks. Attached for your reference is a zoning map showing the areas of the City with an industrial zoning designation. There are significant industrial areas to the south, but also small pockets throughout the City. Staff will be presenting more specific policy options to further define which industrial areas are appropriate for the sale of fireworks, based on safety issues and the compatibility with surrounding land uses. As an example, the City of Des Moines restricts sales of fireworks to industrial-zoned properties and also does not allow sales of fireworks in the Downtown Overlay District. Another approach is a required separation distance from residential property. These approaches will be explored by staff and presented to City Council in greater detail for discussion.

### **Development Services Manager**

Ken DeKeyser begins as our Development Services Manager on Monday, Aug 14. He replaces Joe Mailander in this position, leading the Development Services team. Ken comes to the City from Hall & Hall Engineers, where he was a vice president and survey department lead, and also served as City Engineer for the City of Urbana. Ken is also a former City employee, serving as a Project Engineer in the Public Works Department from 1998 – 2009. Ken received a degree in civil engineering from Iowa State, and a masters in civil engineering from the University of Kansas. Ken reports to Sandi Fowler, and will be working closely with local developers to encourage investment in our community.

### **CRFD Fire Bowl**

The 2017 Cedar Rapids Fire Department Fire Bowl is Saturday, Sept 16, and will be a volleyball tournament at Volley's on Blairs Ferry Road. The tournament starts at 10am and runs until around 8pm. It is a 6 versus 6 format. The 6-player entry fee is \$260, which includes a t-shirt for each player and a guaranteed five games. It will be a pool play, single elimination tournament. The Fire Bowl is open to anyone and everyone—not just Public Safety/Emergency Medical Services teams—so feel free to tell your family and friends so they can put a team together!

The Fire Bowl began in 2010 as a charity 7-0n-7 flag football tournament. It was created by members of the Cedar Rapids Fire Department and is a program operated by the Cedar Rapids Firefighters Foundation. The mission of the Foundation is to have a direct impact on the social, mental and physical well-being of families living in Iowa. The nonprofit organization has donated more than \$150,000 through this event to organizations that assist children right here in Iowa. In 2016, the event format changed from flag football to sand volleyball. The sand volleyball tournament features 100, 6-player teams.

There are many charitable organizations that could use the Foundation's support, so each year there is a new cause to support. This year, the Firefighters Foundation has teamed up with the Cedar Rapids Police Protective Charity and will help fund the Santa Cop program. Held annually at the Target store on Blairs Ferry Road NE, Santa Cop matches underprivileged children in our community with Cedar Rapids police officers to shop for winter necessities.
