Please note the following specification changes/additions/clarifications relative to the above Request for Bid.

- 1) **Revision**: Contractor shall submit pricing on the attached Revised Bid Submittal Form.
- 2) **Revision**: Bids are due before **3:00 pm CDT on Wednesday**, **April 19, 2017**. Reference the RFB for details on submitting a bid.
- 3) **Revision**: Project completion date is August 31, 2017.
- 4) **Change**: The Scope of Work has changed for this project. The Seminole Valley portion will only be road repairs, no sand removal. Ellis Well Field will be sand removal and road repairs.
- 5) *Clarification*: See Attachment F for road repair specifications.
- 6) **Clarification**: Sand that is between the trees and/or that has grass growing on it does not need to be removed. Only sand that is along the bank plus 10 feet +/- on the other side of the road shall be removed. Final site clarification will be provided by the City's Project Manager. Sand shall be removed until Contractor reaches soil.
- 7) **Clarification**: The weigh scale must be certified, but it doesn't need to be a commercial scale. Scale can be placed in the parking lot outside the Ellis well field gate. Coordinate placement with the City's Project Manager.
- 8) *Clarification*: A stormwater protection plan must be provided by the Contractor for this project.
- 9) **Clarification**: Access gate to the well fields can be left open daily.
- 10) *Clarification*: Contractor shall relocate any fallen trees and branches from the river side to the non-river side of the road.
- 11) *Clarification*: Contractor shall construct a loop road turn-around at the end of the Ellis well field road.
- 12) *Clarification*: The City will provide the flood plain permit.
- 13) **Question**: When does the Seminole Valley Park open? Who will open and monitor the gate? **Answer**: Both the park and the gate are open and will remain so during the duration of this project.

14) **Question**: Is a bid bond required?

Answer: No bonds are required for this project.

15) **Question**: Please provide a list of the pre-bid meeting attendees.
