Similarly, the City is not responsible for, and will not open, any bid responses that are received on or after the time stated above. Late submittals will be retained in the RFB file, unopened. No responsibility will be attached to any person for premature opening of a bid not properly identified.
- 1.4 Bids will be publicly opened on Thursday, January 5, 2017 at 3:00 pm (our clock) CST in City Hall, 101 First Street SE, Cedar Rapids 52401. The main purpose of this opening is to read the name(s) of the Bidders(s) and the submitted pricing, not to serve as a forum for determining the apparent low bidder(s).
- 1.5 Bids will be evaluated promptly after opening. After an award is made, a bid tabulation summary will be sent to all companies who submitted a bid. Bid results will not be given over the telephone or prior to award. Bids may be withdrawn any time prior to the scheduled closing time for receipt of bids; no bid may be modified or withdrawn for a period of sixty (60) calendar days thereafter.

## SECTION 2.0 – INSTRUCTIONS TO BIDDERS

2.1 This Project is not federally funded.

## 2.2 NOTICE: INSURANCE IS REQUIRED FOR THIS PROJECT

WORK SHALL NOT BEGIN UNTIL THE CERTIFICATE OF INSURANCE AND ALL REQUIRED ENDORSEMENTS ARE RECEIVED AND APPROVED BY THE CITY.

At all times during the term of the Services and the Contract, and any extensions thereof, the Contractor shall purchase, at its own expense, and maintain with insurance companies in good standing and acceptable to the City. Such insurance will protect the Contractor from liability and claims for injuries and damages which may arise out of or result from the Contractor's operations under the Contract and for which the Contractor may be liable, whether such operations are by the Contractor or by a Subcontractor or by anyone directly or indirectly employed by any of them, or by anyone for whose acts any of them may be liable.

For the protection of the Contractor and the City, but without restricting or waiving any obligations of the Contractor herein contained, the Contractor shall insure the risks associated with the and the Contract with minimum coverages and limits as set forth in Attachment B, INSURANCE REQUIREMENTS.

- 2.3 Whenever used in this RFB the following terms shall have the meaning given as follows: City shall mean the City of Cedar Rapids, Iowa. Contractor shall mean the firm providing Environmental Assessment Services. Subcontractor shall mean any person, firm, or corporation who contracts with the Contractor to perform a service for which the basis of payment or Scope of Services is identified as a part of this RFB. Project Manager shall mean John Riggs, Building Services Manager, who is the designated coordinator and administrator for the Services under this project.
- 2.4 A company representative who is authorized to bind the Company will sign on behalf of the company to indicate to the City that you have read, understand and will comply with the instructions and all terms and conditions stated in this Request for Bid and all attachments.

## 2.5 Pre-Bid Meeting

In addition to the information contained in the Request for Bid, you are strongly encouraged to attend a pre-bid meeting to be held on December 28, 2016 at 1:00 pm at the Best Western Coopers Mill Hotel, 90 F Avenue NW, Cedar Rapids, Iowa. The City is inviting all bidders to attend this meeting to examine the work areas and equipment, ask specific questions and request clarifications on the specification portion of this bid document. All interested bidders are strongly encouraged to attend in order to familiarize themselves with the systems and all conditions that may affect the time or cost of performance.

2.6 This Request for Bid does not commit the City to make an award, nor will the City pay any costs incurred in the preparation and submission of bids, or costs incurred in making necessary studies for the preparation of bids.

## 2.7 Addenda

Any matter of this bid package that requires explanation or interpretation must be inquired into by the Bidder in writing by Thursday, December 29, 2016 at 3:00 pm, CST. FAX or E-MAIL all questions to Judy Lehman at 888-815-3659 or <a href="mailto:i.lehman@cedar-rapids.org">i.lehman@cedar-rapids.org</a>. Any and all questions will be responded to in the form of written addenda to all Bidders. All addenda that you receive shall become a part of the Contract Documents and shall be acknowledged and dated on the bottom of the Signature Page Form (Attachment C). All Addenda will be posted on the City's website. It is the Bidder's responsibility to check for addenda.

## 2.8 Exceptions to Documents

The Bidder shall clearly state in the submitted bid any exceptions to, or deviations from, the minimum bid requirements, and any exceptions to the terms and conditions of this RFB. Such exceptions or deviations will be considered in evaluating the bids. Bidders are cautioned that exceptions taken to this RFB may cause their bid to be rejected.

## 2.9 Silence of Specifications

Commercially accepted practices shall apply to any detail not covered in the specification and to any omission of the specification. Any omission or question of interpretation of the specification that affects the performance or integrity of the service being offered shall be addressed in writing and submitted with the Proposal.

- 2.10 Incomplete Information
  - Failure to complete or provide any of the information requested in this Request for Bid, including references, and/or additional information as indicated, may result in disqualification by reason of "non-responsiveness".
- 2.11 No responsibility will be attached to any person for premature opening of a bid not properly identified.
- 2.12 In the event of conflict, the Special Terms and Conditions shall take precedence over the Standard Terms and Conditions, included herein.

Be advised that any conversations (in reference to this RFB) between bidders and any City employee, City official or City Project Manager, outside of the Purchasing Services Division, during the entire competitive bidding process is strictly prohibited. Such actions will result in removal of the Contractor from the vendors list and rejection of the Contractor's bid. The ONLY official position of the City is that position which is stated in writing and issued by the Purchasing Services Division. No other means of communication, whether written or oral, shall be construed as a formal or official response statement.

## SECTION 3.0 - SPECIAL TERMS AND CONDITIONS

## 3.1 Term of Contract

- 3.1.1 The initial term of the Contract shall commence on the date the City executes the Contract and shall end after Step #3 is completed and the closeout report is received by the City.
- 3.1.2 The Contract may be extended by written mutual agreement by the City and the Consultant.
- 3.1.3 A Contract, prepared by the City and signed by the City Manager, shall become the document that authorizes the Services to begin, assuming the insurance requirements have been met. Each section contained herein, the attachments, and any addenda and the response from the successful Bidder shall also be incorporated by reference into the resulting agreement.
- 3.1.4 The City reserves the right to make changes to the Services to be provided which are within the Project. No assignment, alteration, change, or modification of the terms of the Contract shall be valid unless made in writing and agreed to by both the City and the Contractor. The Contractor shall not commence any additional Services or change the scope of the Services until authorized in writing by the City. Contractor shall make no claim for additional compensation in the absence of a prior written approval and amendment of the Contract executed by both the Contractor and the City. The Contract may only be amended, supplemented or modified by a written document executed by the Contractor and the City Manager.
- 3.1.5 In accordance with the provisions and conditions of the Contract, Contractor shall freely enter into the Contract for the purpose of providing Services to the City and to be compensated for the Services.
- 3.1.6 No price escalation will be allowed during the initial term of the contract. If it is mutually decided to renew beyond the initial period and the Contractor requests a price increase, the Contractor shall provide sufficient written certification and documentation to substantiate the request. Documentation shall include, but not be limited to; actual materials invoices, copies of commercial price lists, provision of appropriate indices, which reflect said increases. The City reserves the right to accept or reject price increases, to negotiate more favorable terms or to terminate without cost, the future performance of the contract.

## 3.2 Contract Forms

- 3.2.1 If a Bidder intends to request that the City of Cedar Rapids enter into any agreement form in connection with the award of this project, the form must be submitted with the Bid for review by the City's legal counsel during the evaluation of Bids. If such agreement requires that payments be remitted to other than the Bidder, the Bidder shall indicate the name and address of the firm to whom Bidder would request payments to be made, and the firm's relationship to the Bidder.
- 3.2.2 Bidders are advised that in the event any such agreement contradicts the City of Cedar Rapids requirements, the bid may be rejected due to the contradiction unless Bidder indicated deletion of such clauses. If agreement form indicated a firm other than the Bidder is Contractor, or payee, the proposed Contractor or payee must also indicate concurrence with the deletion of such clauses.
- 3.2.3 If no agreement form is included with the bid, no such form will be approved by the City during the evaluation or award processes, or following award of contract. If the bid does not indicate the proposed Contractor, vendor or payee to be a person or company other than the Bidder, (1) only the Bidder will be considered as Contractor and (2) payments will be made only to the Bidder to whom the contract is awarded.
- 3.2.4 The City of City Rapids will in no case agree to terms not submitted for review with the bid submittal.

## 3.3 Payment Terms and Invoice Submittal

3.3.1 Payment terms for Services authorized under the contract shall be net forty-five (45) days upon receipt of an acceptable original invoice <u>and</u> after Services are performed, inspected and accepted and all required documentation and reports are received in a format acceptable to the City.

- 3.3.2 Invoices shall include the following information:
  - Consultant name and address
  - Date of Services
  - City PO number
  - Description of Services, including Step number
  - The total amount being invoiced
  - The Project Number / Contract Number (RFB #PUR1216-144)
- 3.3.3 Surcharges (i.e. fuel surcharges, restocking) shall NOT be allowed to be added to invoices as an additional line item.
- 3.3.4 All invoices, and supporting documentation shall be submitted at the intervals as agreed upon:

    or

- 3.3.5 The City may withhold payment for reasons including, but not limited to the following:
  - a) Services that are defective, inaccurate, flawed, unsuitable, nonconforming or incomplete due to negligence of the Contractor;
  - b) Damage for which Contractor is liable under the Contract;
  - c) Valid liens or claims of lien;
  - d) Valid claims of Subcontractors or other persons;
  - e) Delay in the progress or completion of the Services;
  - f) Inability of Contractor to complete the Services;
  - g) Failure of Contractor to properly complete or document any pay request or invoice;
  - h) Any other failure of Contractor to perform any of its obligations under the Contract; or
  - The cost to City, including attorneys' fees and administrative costs, of correcting any of the aforesaid matters or exercising any one or more of City's remedies set forth in the Contract.
- 3.3.6 Actual travel time to and from the Services location is not reimbursable under the Contract.
- 3.4 Treatment of Documents and Records
  - 3.4.1 Ownership

All Documents and other materials prepared by the Contractor in connection with this project are the City's sole property in which the Contractor has no proprietary or other rights or interests. All reports, documents, information, and any materials or equipment furnished to the Contractor by the City shall remain the sole property of the City. Nothing written in this paragraph, however, will be interpreted to 'forbid the Contractor from retaining a single copy of information for its files.

## 3.4.2 Confidentiality

Any individual subcontracted or employed by the Contractor with authorized access to personnel information documents, if any, is given access to use any personnel information in the documents solely for the purpose of performing the Services of the Contract and must not divulge this information to anyone without a need to know. Confidentiality of personnel information contained in the documents shall survive the completion or termination of the Contract subject to applicable state statutes.

## 3.4.3 Disposa

If at any time during the performance of the Contract or following completion or termination of the Contract, Contractor and/or its subcontractors chooses to dispose of Documents, disposal of Documents shall:

- a) comply with any retention requirements of the agreement, and
- b) shall be in a manner such that documents or information in the Documents is unable to be read, interpreted, reproduced, copied or duplicated in any fashion.

## 3.4.4 Access/Retention

During the term of the Contract or following completion or termination of the Contract the Contractor and its Subcontractors, if any, shall maintain all accounting records and other documentation generated in performing the Services under the Contract.

The City or any duly authorized representative of the City shall have access to all such information for the purpose of inspection, audit and copying during normal business hours. All such information shall be retained for five (5) years from the date of final payment and after all other pending matters under the Contract are closed.

This access shall be made available to the City or duly authorized agent and shall be considered incidental to the Scope of Services contained herein. As such, there shall be no additional compensation allowed the Contractor for maintaining this information and allowing the herein described access.

- 3.5 If Project is funded in any way utilizing Federal Funds the Contractor acknowledges that it may be required to submit to an audit of funds paid through the Contract and as may be conducted in accordance with provisions of the Office of Management and Budget Circular A-133 (Audit of States, Local Government and Non-Profit Organizations).

## SECTION 4.0 – SCOPE OF SERVICES, SPECIFICATIONS

## 4.1 Background

The City of Cedar Rapids is seeking Bids from qualified firms to provide Environmental Assessment Services for one (1) commercial property located at 90 F Ave NW, Cedar Rapids, lowa. The four story building, formerly known as the Best Western Coopers Mill Hotel, consists of approximately 44,000 - 48,000 square feet. The property is scheduled to be demolished in the spring of 2017.

## 4.2 Definitions

## 4.3 Scope of Services

- 4.3.1 The Consultant shall, at its sole cost and expense, provide, perform and complete in the manner described and specified, all necessary work, labor, services, transportation, equipment, materials, apparatus, information, data and other items necessary to accomplish the Project as defined below, in accordance with the Scope of Services (hereinafter "Services"). The Services will also include procuring and furnishing all approvals and authorizations, and certificates and policies of insurance as specified herein necessary to complete the Project. Consultant shall provide, perform, and complete all of the Services in a professional manner, consistent with the highest standards of professional practice, and in full compliance with the law and the specifications herein.
- 4.3.2 All Services identified in this RFB will be on a firm fixed pricing basis unless otherwise noted or requested in this RFB or supporting documents. Any deviation from this pricing requirement will disqualify a Bid. Pricing must be submitted on the Bid Pricing Submittal Form (Attachment D).
- 4.3.3 The Environmental Assessment Consultant is required to test every part of the structure inside and out whether or not mentioned in this RFB or supporting documents.
- 4.4 The Scope of Services relating to the Contract shall be broken down as follows:

## 4.4.1 Step #1: Assessment and Testing

This step is to be bid as a Firm Fixed Price.

4.4.1.1 Initial assessment, testing for all suspect asbestos containing building materials (ACM), identifying and categorizing all hazardous household wastes (HHW) and any other hazardous waste identification as specified in this RFB. This includes HHW hazards sampled on the property outside of the structure including light fixtures, signs and other suspect materials. HAZCAT inspections are not required. The initial report shall be made available to the City within 20 business days after the Notice to Proceed.

## 4.4.1.2 Asbestos Related Services

The Assessment Consultant shall inspect the property thoroughly for all suspect asbestos-containing materials through material inspection, sampling, laboratory analysis and documentation including sample locations and report preparation. The Consultant shall provide a written inspection report that includes at a minimum:

- a. photo of the inspected property
- b. description of each sample
- c. sample location

- d. estimated quantity of sampled material
- e. map/diagram identifying each sample location
- f. laboratory analytical reports for all samples
- g. summary of identified asbestos-containing materials
- 4.4.1.3 The inspection shall be conducted in accordance with OSHA Regulation 1926.1101 (Asbestos in Construction) and ASTM E-2356. Three (3) samples of each suspect material (per each homogenous area) shall be collected and analyzed utilizing the positive stop method. Additional samples may be required if suspect materials are uncovered or discovered after the initial report has been issued. Any additional cost incurred by the Consultant shall be part of the original proposed price; no additional testing or mobilization fees shall be allowed.

## 4.4.1.4 Household Hazardous Wastes Identification Services

The Assessment Consultant shall identify, categorize and catalog all household hazardous wastes that are present within the structure and on the parcel. These materials include all chemicals, compounds and gases (both organic and inorganic) that may exist in the interior/exterior of the structure. Examples include, but are not limited to: cleaning supplies, paints, solvents, hydrocarbon based materials, CFC's/refrigerants and propane cylinders. The inspection shall also include an inventory of all fluorescent, mercury vapor, and high intensity discharge light bulbs, mercury capsule thermostats, PCB-containing ballasts, transformers and capacitors.

## 4.4.1.5 PCB Identification Services

The Assessment Consultant shall identify, categorize and catalog all PCB containing equipment that is present within the structure.

## 4.4.1.6 Field Investigation, Sampling, and Testing

The Consultant shall provide for proper chain-of-custody, transportation, storage, and shipping of samples, supplies, and materials originating from each parcel for sample delivery to a third party accredited laboratory facility.

Samples that have been contaminated by the Consultant's operations or procedures will not be considered for reimbursement and shall be re-sampled at no additional cost to the City.

All laboratory facilities performing asbestos analysis shall be certified by the National Institute of Standards & Technology (NIST), National Voluntary Laboratory Accreditation Program (NVLAP), or the American Industrial Hygiene Association (AIHA). Consultant shall provide the name of the laboratory, along with its National Voluntary Laboratory Accreditation Program (NFLAP) code number.

## 4.4.2 Step #2: Pre-Remediation Visual Inspection

## This step is to be bid as a Firm Fixed Price.

Prior to asbestos remediation efforts, the Consultant shall conduct a visual inspection to ensure all required engineering controls have been established and are in proper working order. The Consultant and the Remediation Contractor shall meet at the property to ensure that the Remediation Contractor has the locations and testing results of each identified hazard to be removed. A pre-abatement checklist shall be completed and signed-off on by **both** the Assessment Consultant and Remediation Contractor prior to abatement. This **may** include two trips; (1) To verify quantities with the Remediation Contractor and (2) To ensure engineering controls are in place prior to abatement. If a second trip is required, no additional charges are allowed for this step.

## 4.4.3 Step #3: Post-Remediation Visual Inspection

## This step is to be bid as a Firm Fixed Price.

4.4.3.1 Upon completion of remediation efforts, the Assessment Consultant shall conduct a visual inspection to ensure the Remediation Contractor has properly and completely removed all asbestos containing materials (ACM) identified in the assessment report along with all other identified hazards (HHW). A post-abatement checklist shall be completed and signed-off on by both the Assessment Consultant and Remediation Contractor prior to removal of engineering controls.

4.4.3.2 Post-abatement visual inspections shall be performed in accordance with ASTM E-1368 at a minimum. The City's Project Manager shall be notified when the visual inspection has been completed. A standalone closeout report must be provided for the property within ten (10) business days of the completion of Step #3.

## 4.4.4 Hourly Rate:

At the sole discretion of the City's Building Services Manager or designee there may be times that the Assessment Consultant will need to be called out to do a follow up inspection or advise the City on any number of unknown situations. This hourly rate is for one (1) Consultant and shall be an all-inclusive rate. The hourly rate is not authorized for return trips that resulted from the Assessment Consultant's error on any previous step requirements.

- 4.5 The Services to be performed shall consist of providing environmental assessment services including but not limited to:
  - 4.5.1 Identifying and testing for <u>all</u> suspect asbestos containing building materials whether friable or non-friable
  - 4.5.2 Identifying and categorizing all hazardous household wastes
  - 4.5.3 Identifying PCB containing materials and equipment
  - 4.5.4 Identifying all regulated hazardous waste
  - 4.5.5 Written inspection report
  - 4.5.6 Pre-remediation visual inspection may consist of two trips; (1) To verify quantities with the Remediation Contractor and (2) To ensure engineering controls are in place prior to abatement.
  - 4.5.7 Post-remediation visual confirmation that all asbestos containing materials, household hazardous waste and other listed discoveries have been properly and completely abated and the quantities verified with the Remediation Contractor
  - 4.5.8 Post remediation closeout report
- 4.6 Timely completion of this project is critical to allow the City to move forward with the remediation and demolition services in a timely manner. The report generated from Step #1 will be the specification for the Remediation Contractor.

Steps #2 and #3 will be conducted dependent upon and coordinated with the Remediation Contractor's schedule.

The Services shall be performed diligently and continuously in order that the project is completed within the time frame as specified by the City.

- 4.7 The Services shall be performed in accordance with the requirements, standards, specifications, and schedules set forth, and all applicable regulations or policies of the U.S. Environmental Protection Agency, Iowa Department of Natural Resources, Iowa Workforce Development, or any other regulatory agency that has jurisdiction over the Project.
- 4.8 Required Reports

Service reports that may be submitted include, but are not limited to, facility inspection reports and forms and reports specifically required by a waste disposal facility or the regulatory agency that has jurisdiction over the Services, such as analytical reports, asbestos assessment and protocols, photos and reports, photo logs, and work logs. Payment for services will be contingent upon receipt of all required reports. Reports and forms prepared for regulatory agencies will comply with all applicable regulations, policies, and directives of that agency. Reports SHALL be submitted in a digital format along with one hard copy.

- 4.9 Observations of Operations and Site Activities
  - 4.9.1 The City of Cedar Rapids, The Iowa Department of Natural Resources, the United States Environmental Protection Agency, and Iowa Workforce Development have the right to allow their respective representatives to inspect any of the Consultant's operations, activities, and equipment. Notwithstanding the authority of a regulatory agency to conduct site visits as described above, it is the exclusive right of the City through its Project Manager to communicate contract directions, changes, and final acceptance to the Consultant.

4.9.2 The Consultant shall notify the Project Manager within one (1) working day of any regulatory inspection performed. The Consultant shall notify the Project Manager within one (1) working day of receipt of any citation issued by a regulatory agency to the Consultant or any of its agents or Sub-Consultants relating to any Services performed under the Contract.

## 4.10 Assessment Consultant's Employees

- 4.10.1 The Consultant agrees to staff each project with personnel experienced in the nature of the Services and having appropriate training, skills, and credentials to accomplish the Project objectives. The Consultant will maintain continuity of its staff assigned to the work to the fullest extent possible throughout the term of the Project.
- 4.10.2 The Consultant shall utilize only on-site lead personnel who have completed the 40 Hour OSHA Hazardous Waste Operations training and the 8 Hour OSHA Supervisor training.
- 4.10.3 The Consultant shall utilize only on-site labor personnel who have completed the 40 Hour OSHA Hazardous Waste Operations training, have at least twenty (20) hours supervised on the job training and can demonstrate competencies to the Project Manager.
- 4.10.4 The Consultant shall be equipped with the normal tools of their trade and shall furnish all labor, tools, and other items necessary for and incidental to executing and completing all required work.
- 4.10.5 The Consultant shall be responsible for providing protective gear and equipment to its agents and employees and for ensuring its proper utilization in the event of an encounter with asbestos in the debris being removed containing (and suspected to contain) asbestos material under this Project.
- 4.10.6 The Consultant shall utilize only on-site lead personnel who are certified in the State of lowa to conduct asbestos inspections.
- 4.10.7 The Consultant shall utilize only on-site lead personnel who are proficient and show experience in EPA Resource Conservation and Recovery Act (RCRA) regulations for identification of HHW and PCB containing materials. The Consultant is required to show proof of experience in dealing with RCRA regulations and inspections on the General Company Information Page.
- 4.10.8 The Consultant will be provided access to the property for the purpose of observations, testing and assessments necessary to complete the work. The Consultant will fully and sufficiently inform itself of the nature of the work and the hazards inherent in performing the work, and shall inform all its agents and Sub-Consultants of the same.
- 4.10.9 Services performed by the Consultant under the Contract shall be conducted in a manner consistent with the level of care and skill ordinarily exercised by professionals practicing under similar conditions and in strict accordance with applicable laws, regulations, and rulings.
- 4.10.10 Consultant's employees must be identifiable by uniform, proper identification and a marked vehicle. If, in the opinion of the City, an employee of the Consultant is incompetent or disorderly, refuses to perform in accordance with terms and conditions of the contract, threatens or uses abusive language while performing work on this project, that employee shall be removed from all work under the contract.

## SECTION 5.0 – BID EVALUATION AND AWARD

- 5.1 Award Any award(s) made by the City of Cedar Rapids is subject to prior approval by the City of Cedar Rapids City Council.
  - 5.1.1 Award shall be made to the responsible Bidder submitting the lowest responsive bid with regard to the specifications set forth herein. The City reserves the right to accept or reject any or all bids; to request rebids; to award bids item-by-item, by groups or lump sum; and to waive technicalities and formalities where is it deemed advisable in protection of the best interests of the City.
  - 5.1.2 If the evaluation team determines that the project should be awarded, the process shall be as follows:
    - a) The evaluation team shall determine which responsible Bidder has submitted the lowest responsive bid.
    - b) For projects equal to or greater than \$50,000, the City Council shall consider a resolution awarding the contract and authorizing the City Manager to sign the Contract on behalf of the City. Note, as provided for by Section 4.03 of the Cedar Rapids Municipal Code, no Contract shall be deemed to be created and exist, unless and until the City Council adopts a resolution awarding the project and authorizing the City Manager to sign the Contract.
    - c) The City Manager executes the Contract.
    - d) The City issues a purchase order to the Contractor. The purchase order shall constitute authorization for the Contractor to commence the Services.
  - 5.1.3 If the evaluation team determines that all the bids received should be rejected, the Bidders shall be notified by the Purchasing Services Division accordingly. At that point, the City may, or may not, re-bid the project.
- 5.2 Award of bid shall be made to the lowest responsive and responsible Bidder(s) meeting the specifications set forth herein. In addition to the quoted price, the following is a partial list of the criteria that may be used in our determination of Contractor responsibility and responsiveness:
  - · Service specifications as specified in these bid documents;
  - · Company's reputation and financial status;
  - Company's ability to meet the City's Insurance Requirements;
  - Past experience and service provided by Bidder;
  - Favorable references from firms with projects of similar scopes that indicate that the Bidder has the ability to carry out the Services and provide the products specified;
  - Strength of company's safety program and history.
- 5.3 The City of Cedar Rapids reserves the right to use both primary and secondary suppliers or to otherwise use multiple sources to protect the City's overall interests.
- The Company must not have any unresolved performance issues with the City of Cedar Rapids. The Company's performance as a prime Contractor or subcontractor in previous City contracts shall be taken into account when evaluating the Company's submittal for this Request for Bid. The City may survey other local agencies during the bid evaluation period to make sure the Company does not have any unresolved or unsatisfactory performance issues. The City reserves the right to reject the Company's submittal based on its assessment of the Company's prior performance.
- In case of tie bids, the City will make the award based on the priority factors as outlined in the City of Cedar Rapids Purchasing Policy Manual.

## ATTACHMENT A - STANDARD TERMS AND CONDITIONS

ACCELERATED PAY DISCOUNTS - Accelerated discounts should be so stated on the Signature Page. If quick pay discounts are offered, the City reserves the right to include that discount as part of the award criteria. Prices bid must, however, be based upon payment in net forty-five (45) days after receipt, inspection and acceptance. In all cases, quick pay discounts will be calculated from the date of the invoice or the date of acceptance, whichever is later.

## **ADA COMPLIANCE**

- 1. The Contractor shall comply with all applicable provisions of the Americans with Disabilities Act (Public Law 101-336, 42 U.S.C. 12101 et seq.) and applicable Federal regulations under the Act.
- Bids for design, construction, programs, policies and concessions of any type shall comply with the 2010 Standards for Accessible
  Design, the ADA title II regulation, Section 504 of the 1973 Rehabilitation Act, and similar statutes and regulations prohibiting
  discrimination on the basis of disability.
- The Contractor shall ensure that its websites and all online services, including those websites or online services provided by third
  parties upon which Cedar Rapids relies to provide services or content, comply with , at minimum, Web Content Accessibility
  Guidelines WCAG 2.0 AA.

ASSIGNMENT - The City and the Contractor each is hereby bound and the partners, successors, executors, administrators and legal representatives of the City and the Contractor are hereby bound to the other Party to the Contract and to the partners, successors, executors, administrators and legal representatives (and said assigns) of such other Party, in respect of all covenants, agreements and obligations of the Contract. Any assignment or attempt at assignment made without prior written consent of the City shall be void.

**BID CURRENCY/LANGUAGE** - All bid prices shall be shown in US Dollars (\$). All prices must remain firm for the duration of the contract regardless of the exchange rate. All bid responses must be submitted in English.

**BID FORM** - Each Bidder must submit an original bid and additional copies as required on the forms attached. The Bidder shall correctly sign the bid, and the bid may be rejected if it shows any omissions, alterations of the form, additions not called for in the bid, or any irregularities of any kind. In case of a discrepancy between the unit price and the extended price, the unit price shall prevail.

BID INFORMATION IS PUBLIC - All documents submitted with any bid shall become public documents and subject to Iowa Code Chapter 22, which is otherwise known as the "Iowa Open Records Law". By submitting any document to the City of Cedar Rapids in connection with a bid, the submitting party recognizes this and waives any claim against the City of Cedar Rapids and any of its officers and employees relating to the release of any document or information submitted. Each submitting party shall hold the City of Cedar Rapids and its officers and employees harmless from any claims arising from the release of any document or information made available to the City of Cedar Rapids arising from any opportunity. Bid information requested by the public or other bidders will be provided in an alternative format if the requestor is a person with a disability and requires an alternative form for comprehension.

**BID REJECTION OR PARTIAL ACCEPTANCE** - The City reserves the right to accept or reject any or all bids or parts thereof. The City further reserves the right to waive technicalities and formalities in bids, as well as to accept in whole or in part such bids where it is deemed advisable in protection of the best interests of the City.

CONFLICT OF INTEREST - Contractor represents, warrants, and covenants that no relationship exists or will exist during the Contract period between the Contractor and the City that is a conflict of interest. No employee, officer or agent of the Contractor shall participate in the selection or in the award if a conflict of interest, real or apparent, exists. The provisions of lowa Code ch. 68B shall apply to the Contract. If a conflict of interest is proven to the City, the City may terminate the Contract, and Contractor shall be liable for any excess costs to the City as a result of the conflict of interest. The Contractor shall establish safeguards to prevent employees, consultants, or members of governing bodies from using their positions for purposes that are, or give the appearance of being, motivated by the desire for private gain for themselves or others with whom they have family, business, or other ties. The Contractor shall report any potential, real, or apparent conflict of interest to the City.

DISPUTES - Should any disputes arise with respect to the Contract; the Parties agree to act immediately to resolve such disputes. Time is of the essence in the resolution of disputes. The Contractor agrees that, the existence of a dispute notwithstanding, it will continue without delay to carry out all of its responsibilities under the Contract that are not affected by the dispute and the City shall continue to make payment for all Services properly performed. Should the Contractor fail to continue to perform its responsibilities regarding all non-disputed Services, without delay, any additional costs incurred by the City or the Contractor as a result of such failure to proceed shall be borne by the Contractor. The unintentional delayed payment by the City to the Contractor of one or more invoices not in dispute in accordance with the terms of the Contract will not be cause for Contractor to stop or delay Services.

FOB POINT AND FREIGHT/DELIVERY CHARGES – The FOB point, in terms of loss or damage, as well as where title to the goods is passed, shall be FOB-Destination. Freight/delivery charges are to be included in the quoted price of the goods, rather than as a separate line item.

FORCE MAJEURE - Force majeure shall be any of the following events: acts of God or the public enemy; compliance with any order, rule, regulation, decree, or request of any governmental authority or agency or person purporting to act therefore; acts of war, public disorder, rebellion, terrorism, or sabotage; floods, hurricanes, or other storms; strikes or labor disputes; or any other cause, whether or not of the class or kind specifically named or referred to herein, not within the reasonable control of the Party affected. A delay in or

failure of performance of either Party shall not constitute a default hereunder nor be the basis for, or give rise to, any claim for damages, if and to the extent such delay or failure is caused by force majeure. The Party who is prevented from performing by force majeure shall be obligated, within a period not to exceed fourteen (14) days after the occurrence or detection of any such event, to give notice to the other Party setting forth in reasonable detail the nature thereof and the anticipated extent of the delay, and shall remedy such cause as soon as reasonably possible, as mutually agreed between the Parties.

**INDEMNIFICATION** - The Contractor shall, and hereby agrees to, protect, defend, indemnify and hold harmless the City of Cedar Rapids; its officers and employees from any and all claims, settlements, judgments, and damages of every kind and nature made, to include all costs associated with the investigation and defense of any claim, rendered or incurred by or on behalf of the City, its officers, and employees, that may arise, occur, or grow out of any errors, omissions, or acts, done by the Contractor, its employees, or any independent Contractors working under the direction of either the Contractor in the performance of the Contract.

LAWS AND REGULATIONS - The Contract shall be governed, interpreted and enforced in accordance with all applicable federal, State of lowa, and local laws, ordinances, licenses and regulations of a governmental body having jurisdiction and shall apply to the Contract throughout, as the case may be. The Contractor certifies that in performing the Contract they will comply with all applicable provisions of the federal, state, and local laws, regulations, rules, and orders.

**METHOD OF AWARDING -** The City reserves the right to make awards based on the entire bid or on an item by item basis. However if Contractor's bid is based on an "all or none" condition, the City may consider their bid non-responsive and reject the entire bid.

**NO GIFT STANDARD** - The City of Cedar Rapids is committed to upholding the highest ethical standards in all of its business practices. This standard recognizes the need to avoid even the perception of improper gifts or favors to employees. Therefore, all suppliers have been asked to abide by the City's "No Gift" standard. The "No Gift" standard also applies to all offers of discounts or free items at any place of business targeted toward a City employee and not available to the general public, regardless of the value.

NON-COLLUSION STATEMENT – Neither the Contractor, nor anyone in the employment of the Contractor, has employed any person to solicit or procure the Contract nor will the Contractor make any payment or agreement for payment of any compensation in connection with the Contract. There is no contract, agreement or arrangement, either oral or written, expressed or implied, contemplating any division of compensation for Services rendered under the Contract or participation therein, directly or indirectly, by any other person, firm or corporation, except as documented in the Contract. Neither the Contractor, nor anyone in the employment of the Contractor, has either directly or indirectly entered into any agreement, participated in any collusion or otherwise taken any action in restraint of free competitive procurement in connection with the Contract.

NON-DISCRIMINATION AND EQUAL OPPORTUNITY - All Contractors that engage in contracts with the City of Cedar Rapids, lowa agree as follows: The Contractor will not discriminate against any employee or applicant for employment because of race, sex, color, creed, ancestry, national origin, marital status, families with children, religion, age, disability, sexual orientation, gender identity, genetic information, status with regard to public assistance, status as a veteran or any classification protected by federal, state, or local law, (Protected Classes) except where age and sex are essential bona fide occupational requirements, or where disability is a bona fide occupational disqualification. Such action shall include, but not be limited to the following; (a) Employment, (b) Upgrading, (c) Demotion or transfer, (d) Recruitment and advertising, (e) Layoff or termination, (f) Rate of pay or other forms of compensation, and (g) Selection for training, including apprenticeship. The Contractor further assures that managers and employees comply with both the spirit and intent of federal, state, and local legislation, government regulation, and executive orders in providing affirmative action as well as equal opportunity without regard to the protected classes, as stated above. The Contractor will include, or incorporate by reference, the provisions of the nondiscrimination clause in every contract or subcontract unless exempt by the rules, regulations or orders of the City's Affirmative Action Program and will provide in every contract or subcontract that said provision will be binding upon each Contractor.

REGULATORY AGENCY COMPLIANCE - Compliance with laws and regulations set forth by regulatory agencies is required. These agencies include, but are not limited to, OSHA – Occupational Safety & Health Agency, EPA – Environmental Protection Agency, ICC – Interstate Commerce Commission, DNR – Department of Natural Resources, and DOT – Department of Transportation. The City of Cedar Rapids expects that Contractors will offer expertise on conformance of regulations applying to the products they sell and the Services they perform.

SAFETY DATA SHEETS - The Hazard Communication Standard (HCS) requires chemical manufacturers, distributors, and importers to ensure that each container of hazardous chemicals leaving the workplace is labeled, tagged, or marked and to provide Safety Data Sheets (SDS) to communicate the hazards of hazardous chemical products. It is the chemical supplier's responsibility to determine which products are covered and to provide SDS with the initial shipment. It is also the chemical supplier's responsibility to provide any updated or revised SDS, as they become available for any products sold and delivered to the City of Cedar Rapids. City of Cedar Rapids employees shall not accept a shipment of any chemical that does not have a SDS attached or currently on file. Safety Data Sheets shall be available in alternative formats if the requestor is a person with a disability and requires an alternative format for comprehension.

**SUBCONTRACTING** — The Services relating to this Project, or any portion thereof, may not be subcontracted without written approval from the City. All approved Subcontractors shall be listed in the resulting contract or in a written amendment to the contract.

**SPECIFICATIONS** - Unless otherwise stated, every item provided in response to this Request for Bid shall be new, unused, and of current model under standard production by the manufacturer. Items shall be furnished complete with standard equipment and accessories as listed in the manufacturer's printed literature. Remanufactured, used, demonstrator models or refurbished items will not be accepted.

SUSPENSIONS AND DEBARMENT - The Contractor hereby certifies, pursuant to 2 CFR pt. 180 and 2 CFR pt. 3000, that neither it nor its principles are presently debarred, suspended, proposed for debarment, declared ineligible, or voluntarily excluded from participation in the Contract by any federal agency. The Contractor further certifies that it is not presently debarred, suspended, proposed for debarment, declared ineligible, or voluntarily excluded from participation in any contracts with the City of Cedar Rapids or the State of lows.

**TAXES** - The City of Cedar Rapids is exempt from sales tax and certain other use taxes. Any charges for taxes from which the City is exempt will be deducted from invoices before payment is made. The Cedar Rapids Tax ID number is 42-6004336.

TERMINATION OF CONTRACT FOR CONVENIENCE - The City may terminate the Contract at any time by giving written notice to the Contractor of such termination and specifying the effective date thereof, at least thirty (30) calendar days before the effective date of such termination. In that event, all finished or unfinished Services, reports, materials(s) prepared or furnished by the Contractor under the Contract shall, at the option of the City, become its property. If the Contract is terminated by the City as provided herein, the Contractor shall be paid for all Services which has been authorized, provided, and approved up to the effective date of termination. The City will not be subject to any termination fees from the Contractor.

TERMINATION FOR CAUSE AND DEFAULT - If through any cause, the Contractor shall fail to fulfill in a timely and proper manner its obligations or if the Contractor shall violate any of the terms or conditions of the Contract, the City shall thereupon have the right to terminate the Contract by giving written notice to the Contractor of such termination and specifying the effective date of termination. In that event, and as of the time notice is given by the City, all completed Services, reports, and delivered materials shall, at the option of the City, become its property, and the Contractor shall be entitled to receive compensation for any satisfactory Services completed. Notwithstanding the above, the Contractor shall not be relieved of liability to the City for damage sustained by the City by virtue of breach of the Contract by the Contractor and the City may withhold any payments to the Contractor for the purpose of set off until such time as the exact amount of damages due the City are determined.

WARRANTIES -- SERVICES - The Contractor shall perform Services for the City pertaining to the Project as set forth in the Contract. Contractor represents that the Services and all of its components shall be free of defects; shall be performed in a manner consistent with other Contractors in a similar industry and application; and shall conform to the requirements of the Contract.

Contractor shall be responsible for the quality, technical accuracy, completeness and coordination of all Services performed under the Contract. Contractor shall, promptly and without charge, provide all corrective Services necessary as a result of Contractor's acts, errors, or omissions with respect to the quality and accuracy of the Services.

Contractor shall be responsible for any and all damages to property or persons as a result of Contractor's acts, errors, or omissions, and for any losses or costs to repair or remedy any Services undertaken by City based upon the Services as a result of any such acts, errors, or omissions.

Contractor's obligations shall exist without regard to, and shall not be construed to be waived by, the availability or unavailability of any insurance, either of City or Contractor.

WARRANTIES – INTELLECTUAL PROPERTY - Contractor represents and warrants that all the materials, goods and Services produced, or provided to the City pursuant to the terms of the Contract shall be wholly original with the Contractor or that the Contractor has secured all applicable interests, rights, licenses, permits or other intellectual property rights in such materials, goods and Services. The Contractor represents and warrants that the materials, goods and Services, and the City's use of same, and the exercise by the City of the rights granted by the Contract shall not infringe upon any other Services or violate the rights of publicity or privacy of, or constitute a libel or slander against, any person, firm, or corporation. Contractor further represents and warrants that the materials and Servicess do not infringe upon the copyright, trademark, trade name, trade dress patent, statutory, common law or any other rights of any person, firm or corporation or other entity. The Contractor represents and warrants that it is the owner of or otherwise has the right to use and distribute the goods and Services contemplated by the Contract.

## ATTACHMENT B – INSURANCE REQUIREMENTS

## Section I - Basic Insurance Requirements

Contractor, at its own expense, shall procure and maintain during the life of this Contract, the following insurance so as to cover all risk which shall arise directly or indirectly from Contractor's obligations and activities.

<u>General Liability</u> Insurance Contractor shall carry the most recently approved ISO Commercial General Liability Insurance policy, or its equivalent, written on an occurrence-basis, with limits not less than \$1,000,000 per occurrence/\$2,000,000 general aggregate for Bodily Injury and Property Damage, including the following coverages:

- Premises and Operations Coverage
- Contractual Liability
- Products and Completed Operations Coverage
- Broad Form Property Damage Liability
- Personal Injury Liability
- Sudden and Accidental Pollution Liability

<u>Automobile Liability</u> Insurance with a combined single limit of at least \$1,000,000 per occurrence for bodily injury and property damage. Coverage shall include all owned, hired, and non-owned motor vehicles used in the performance of this contract by the Contractor or its employees.

<u>Workers Compensation</u> and Employers Liability Insurance meeting the requirements of the lowa Workers Compensation Statutes. The coverage limits shall include \$500,000 each accident for Bodily Injury by Accident, \$500,000 each employee for Bodily Injury by Disease, and \$500,000 policy limit for Bodily Injury by Disease.

<u>Pollution Liability</u> Insurance with limits of at least \$1,000,000 per occurrence. Coverage shall include claims for bodily injury, property damage, environmental damage and cleanup expenses (including investigation, removal, remediation, monitoring and disposal) of any spill, release, discharge or dispersal arising out of Contractor's (including its employees and subcontractors) Work. This insurance will not exclude or limit coverage for asbestos, lead, or mold and will affirmatively include non-owned disposal site coverage, transportation, loading and unloading of waste or materials generated by the Contractor's Work at the job site.

## **THREE (3) ENDORSEMENTS REQUIRED:**

## 1. Additional Insured Endorsement:

Except for Workers' Compensation and Professional Liability, the policies shall include the City Additional Insured Endorsement of: The City of Cedar Rapids, Iowa, including all its elected and appointed officials, all its employees and volunteers, all its boards, commissions and/or authorities and their board members, employees, and volunteers, are included as additional insureds with respect to liability arising out of the Insured's work and/or Services performed for the City of Cedar Rapids, Iowa. This coverage shall be primary to the additional insureds, and not contributing with any other insurance or similar protection available to the additional insureds, whether available coverage be primary, contributing, or excess.

## 2. Non-Waiver of Governmental Immunities Endorsement (Iowa):

- a. <u>Non-waiver of Government Immunity</u> The insurance carrier expressly agrees and states that the purchase of this policy and the including of the City of Cedar Rapids, Iowa as an Additional Insured does not waive any of the defenses of governmental immunity available to the City of Cedar Rapids, Iowa under Code of Iowa Section 670.4 as it now exists and as It may be amended from time to time.
- b. <u>Claims Coverage</u> The insurance carrier further agrees that this policy of insurance shall cover only those claims not subject to the defense of governmental immunity under the Code of Iowa Section 670.4 as it now exists and as may be amended from time to time.
- c. <u>Assertion of Government Immunity</u> The City of Cedar Rapids, lowa shall be responsible for asserting any defense of governmental immunity, and may do so at any time and shall do so upon the timely written request of the insurance carrier. Nothing contained in this endorsement shall prevent the carrier from asserting the defense of governmental immunity on behalf of the City of Cedar Rapids, Iowa.
- d. Non-Denial of Coverage The insurance carrier shall not deny coverage under this policy and the insurance carrier shall not deny any of the rights and benefits accruing to the City of Cedar Rapids, lowa under this policy for reasons of governmental immunity unless and until a court of competent jurisdiction has ruled in favor of the defense(s) of governmental immunity asserted by the City of Cedar Rapids, Iowa.

e. <u>No Other Change in Policy</u> The insurance carrier and the City of Cedar Rapids, Iowa agree that the above preservation of governmental immunities shall not otherwise change or alter the coverage available under the policy.

## 3. Cancellation and Material Changes Endorsement

Thirty (30) days Advance Written Notice of Cancellation, Non-Renewal, Reduction in insurance coverage and/or limits and ten (10) days written notice of non-payment of premium shall be sent to:

## Section II - Conditions of Contract

The Contractor is required to purchase and maintain insurance coverage to protect the Contractor and City of Cedar Rapids throughout the duration of this Contract as enumerated above in the minimum limits above written and the requirement shall be a part of the Contract. Failure on the part of the Contractor to maintain this insurance in full effect will be treated as a failure on the part of the Contractor to comply with these requirements and be considered sufficient cause to suspend the work, withhold payment(s), and/or be disqualified in the future.

The insurance policies shall be issued by insurers authorized to do business in the State of Iowa and currently having an A.M. Best Rating of "B+" or better. All policies shall be occurrence form. If Professional Liability coverage is written on a claims made policy form, the certificate of insurance must clearly state coverage is claims made and coverage must remain in effect for at least two years after final payment with the Contractor continuing to furnish the CITY certificates of insurance.

The Contractor shall be responsible for deductibles and self-insured retentions in the Contractor's insurance policies.

The Contractor is required to give the City notice of any change in coverage, specifically, any reduction in coverage and cancellation of coverage no less than thirty (30) days prior to the effective date of any non-renewal or cancellation of any policies required by the Contract.

The City intends to be an Additional Insured with coverage being primary and not contributing with any other insurance or similar protection available to the City whether any other coverage is primary, contributing or excess.

In the case of any work sublet, the Contractor shall require subcontractors and independent contractors working under the direction of either the Contractor or a subcontractor to carry and maintain the same workers compensation and liability insurance required of the Contractor.

## Section III - Contract Approval

A Certificate of Insurance is required evidencing all required insurance coverage as provided above with any required endorsements attached so as to evidence their inclusion in the coverage. The Certificate of Insurance is due before the Contract can be approved. The following format is required:

The Cedar Rapids City Council adopted the Buy Local Purchasing Policy through City Council Resolution No. 1239-10-10.

## 1. Who is local?

- a. Businesses located within Linn County, Iowa who have paid Linn County property taxes on a plant, office or store occupied by the business for the past year; or
- b. Businesses located within Linn County, lowa who have paid rent for the past year to a landlord or owner who has paid Linn County property taxes for the past year on the plant, office or store occupied by the business.

## 2. How do I apply for local preference status?

- a. Complete a "Local Business Certificate". (See page 3 of this packet)

## 3. After I return the notarized certificate, how do I know if my business is on the list?

## 4. Will the local preference policy be applied to all purchases for goods and services?

No, the following types of purchases are excluded:

- a. Purchases subject to the competitive laws of the State of Iowa
- b. Purchases subject to federal, state or county grant stipulations
- c. Purchases from the State of Iowa or other national contracts
- d. Sole source purchases

## 6. If I work out of my home, and my home is in Linn County, am I eligible to become a certified local business?

In order to qualify as local business your business must pay commercial property taxes related to the business being certified as local business. Residential property taxes paid for a home business do not qualify for the buy local certification.

## 7. How does the Buy Local Program work?

Preference shall be applied to acceptable quotes, bids and proposals greater than \$1,000 from businesses within Linn County, Iowa who have submitted a notarized "Local Business Certificate".

**Example A:** Preference shall be given in the procurement of goods and/or services by <u>bid or quote</u> when a local Contractor's bid or quote exceeds the acceptable low bid by no more than:

10% for bids less than \$25,000

5% for bids equal to or greater than \$25,000 but less than \$200,000

1% for bids equal to or greater than \$200,000

## STATEMENT OF POLICY

## CITY OF CEDAR RAPIDS LOCAL BUSINESS CERTIFICATE

Pursuant to Cedar Rapids City Council Resolution 1239-10-10, in conducting the procurement of goods and/or services by competitive solicitation, the City of Cedar Rapids shall give preference to a responsive bid or proposal from a business located within the limits of Linn County, lowa over an acceptable bid or proposal submitted by a business located outside of Linn County.

Preference shall be given in conducting procurement of goods and/or services by bid or quote when a local bidder's bid or quote exceeds the acceptable low bid by no more than:

- 10% for bids less than \$25,000
- 5% for bids equal to or greater than \$25,000 but less than \$200,000
- 1% for bids equal to or greater than \$200,000

Preference shall be given in conducting procurement of goods and/or services by request for proposal by awarding additional points to each proposal where the business is located in Linn County as follows:

- 10% of all available points for proposals less than \$25,000
- 5% of all available points for proposals equal to or greater than \$25,000 and less than \$200,000
- 1% of all available points for proposals equal to or greater than \$200,000

The local preference is not applicable to goods and services purchased with the assistance of federal, state or county grants or funds, or pursuant to the competitive laws of the State of Iowa.
