Comments and clarifications from pre-bid meeting held February 27, 2018:

- Contractor shall be responsible for moving of furniture.
- A copy of the floor plan for the carpeted area is provided as Attachment E to the RFB. The work area included in the scope of work is highlighted in yellow.
- The rubber Mondo flooring in the locker room area will remain as it is. It will not be replaced with carpet.
- Alternate pricing is requested for carpet tile. See revised pricing submittal form on page 2 of this Addendum. The revised form replaces page 22 in the RFP document.
