The following questions and/or clarifications were asked relative to the above-listed Request for Bid. This memo is sent for clarification to all companies to whom the bid was sent.

## **Notes from Pre-Bid Meeting:**

- Transfer switch shall be the same as the generator manufacturer. And shall be service rated.
- Sound and weatherproof requirements shall meet code.
- Stop at generator not required.
- Remote annunciator shall be located inside of station and on unit itself.
- Intent of new unit is to run entire facility on back up.
- Current units only run minimal equipment to operate.
- Work shall be completed during regular business hours. Intent is to keep station occupied/operational during installation.
- Contractor may need to move existing unit to place new unit. 3-4 days without back up acceptable. 2 weeks without back-up maximum.
- 2 stations down at a time is acceptable.
- All units shall be 60KW minimum as specified to allow for future expansion of needs.
- Station #7, conduit shall be surface mounted in bay and above drop ceiling in living quarters.
- Station #6 conduit outside is painted red. New conduit does not need to be painted.
- All units shall be Cummins Power Connect RX60 or equivalent.
- City has SNMP trap monitor in place.
- Contractor shall provide a firm fixed price for a Cummins Power Command 500 or equivalent for each unit. Contractor shall refer to the Revised Attachment C.
