- High quality proposal presentation with City of Cedar Rapids data used to customize content
- Previous experience working with the City of Cedar Rapids on economic development strategic plan
- Project team has sufficient experience but it is unclear if the assigned project manager would remain the same for the duration of the project
- Sample report documents are not a complete representation of what final product would look like
- Financial proposal is higher than competitive range and does not include all expenses
- Initial market analysis to be completed by 12/15/18 but timeline for final project completion is unclear

- Project team has extensive experience and proven track record with consistent Project Manager
- Proposal covers all aspects described in the RFP and presents a clear methodology and understanding of the project
- High quality proposal presentation with complete sample report documents for relevant projects
- Financial proposal is within competitive range and inclusive of all expenses
- Clear timeline indicates draft report to be delivered to the City by 12/15/18 and final report to be completed by 1/31/19.

3. Weitzman Associates, LLC

Facts:

- Project team is clearly knowledgeable but proposal does not indicate strong experience that is specifically relevant to this project
- Proposal seems to focus more on pre-development planning for specific projects rather than overall market analysis
- Sample projects included in proposal do not include housing market analysis
- Financial proposal is higher than competitive range
- Anticipate submitting a draft report of preliminary findings and recommendations by 12/15/18 but timeline for final project completion is unclear

Recommendation for Award:

The evaluation team scored the top ranked proposals and Maxfield Research & Consulting was rated as the top proposal. A contract will be executed with Maxfield Research & Consulting.
