Please note the following specification changes/additions/clarifications relative to the above Request for Bid.

Prebid Meeting was held February 17, 2021 at 10am at Tait Cummins Sports Complex. List of attendees is attached. The following questions were received and answered:

Question: How flexible is the May 31<sup>st</sup> completion date?
Answer: The only exceptions on lighting would be frost conditions preventing pole testing

2) **Question**: Is the contractor required to pay City permit fees? **Answer**: Contractor needs to obtain an electrical permit, but the permit fee will be waived.

**CLARIFICATION:** Not later than May 9, 2021, the contractor needs to have power safely restored to the facility with existing lighting made functional for at least two ballfields for evening and weekend play. Balance of work to be completed by May 31, 2021.

**REPLACE:** Bid Pricing Submittal Form with attachment. Contractors must submit their pricing on the Revised Bid Pricing Submittal Form. Failure to do so will result in Contractor's bid being non-responsive.

All addenda that you receive shall become a part of the contract documents and shall be acknowledged and dated on the bottom of the Signature Page (Attachment B). The deadline for sealed bids is Wednesday, February 24, 2021, before 11:00 am CST at the Purchasing Services Division, 101 First Street SE, Cedar Rapids, IA 52401.
